**Position Summary:**

- Assist with installation, service, repair & inspection of fire sprinkler systems under direct supervision
- Position is expected to bill a minimum of 40 hours per week on projects, with typical hours from 8am to 5pm with a one-hour lunch. The start and stop times of your workday may be altered by your Supervisor

**Job Duties (General):**

- Assist with threading pipe, cutting rod, reading blueprints, assisting foreman with hanging pipe, cleaning work area and equipment
- Assist with installation, repair and maintenance of all types of fixed extinguishing systems, including underground piping
- Assist with installing and servicing a variety of fire protection equipment such as standpipes, wet pipe systems, dry pipe systems, pre-action systems and foam systems
